**PUBLIC PARTICIPATION FOR KIAMBU ALCOHOLIC
DRINKS CONTROL BILL, 2017**

Pursuant to Part 2 of the Fourth Schedule to the Constitution of Kenya, 2010 and Section 87 of the County Government Act, and Section 15 of the Kiambu County Citizens Petitions and Public Participation Act, 2017, the County Government of Kiambu invites interested parties and the general public to submit their written memorandum and or participate in the public participation forums as per this notice to discuss the Kiambu County Alcoholic Drinks Control Bill, 2017.

The proposed Bill shall address the systems of licensing and directly or indirectly affect any person manufacturing, distributing, selling on wholesale or retail or any other manner dealing with an alcoholic drink within the County. Upon implementation, the law will affect any person currently or intending in future to deal with an alcoholic drink within the County.

Offices of the Sub County administrators shall be available at office working hours to assist any person who is unable to read or access the aforementioned Bill.

Written memorandum can be submitted to the offices of the Sub County administrators within **21 days (Twenty One Days)** from the date of this notice.
