Item C.- Allow a provisional sum of KShs Seven Hundred and Fifty Thousand (KSh 750,000) only for Mechanical Works Item D. - Provide the Provisional Sum of Kshs. Four Hundred Thousand only (Kshs.400,000) for Stormwater Drainage works
