Through this notice, we invite members of the public, private sector organizations, interested parties, and all key stakeholders to submit their plan proposals for inclusion in the County Annual Development Plan for the financial year 2025-2026.

To facilitate timely consultations and adequate consideration, written proposals should be submitted to the undersigned at Red **Nova offices, Kiambu (Finance Block)** and soft copies of the proposals should be sent via email to [public.participation@kiambu.go.ke](mailto:public.participation@kiambu.go.ke) and a copy to [economicplanningkiambu@gmail.com](mailto:economicplanningkiambu@gmail.com) to be received not later than 22<sup>nd</sup> August, 2024.
