PRELIMINARIES.

MIN. 1/4/8/2024 - JUJA TOWN DECONGESTION

Following deliberation by the municipal board it was noted that there has been persistent traffic jam and congestion at the Juja Fly over during peak hours. The board agreed to adopt a multi-disciplinary approach in resolving the menace. It was agreed to pay the Juja traffic commander a courtesy call to deliberate possible solution to address the issue.

MIN. 2/5\8\2024 - ILLEGAL STRUCTURES MENACE

The municipal board chair informed the committee on the mushrooming of illegal structures near the juja bustage and specific zones in the juja CBD. It was it was agreed upon that the municipal manager in liaison with the planning team to issue enforcement notices to the illegal structure owner to vacate the road reserves before beginning of the new year

MIN 3/6/8/2024 - FLOODING

In preparation to the oncoming rainy season, it was agreed that the municipal manager should engage the department of roads and public works team in unclogging all blocked storm water drainages within the Juja CBD areas and any flood prone areas in the municipality.

MIN 4/7/8/2024- CAPACITY DEVELOPMENT

It was noted that there is great need for capacity development for the Juja board members. Specific areas of training agreed upon including, fiduciary management and donor funded program reporting, environmental and social safeguards, legal framework related to physical planning, valuation, surveying and other land related matters. The municipal manager was tasked to do requisition to the executive for facilitation.
