MIN 6/02/5/2024 GRIEVANCE REDRESS MECHANISM MUNICIPALITY POLICY


The Chairperson Dr. Gachanja tabled the Municipal Grievance Redress Mechanism (GRM) policy, members reviewed and adopted it
