**AN ACT of the County Assembly of Kiambu to authorize the issue of
further sums required to be voted for the service of the year
ending on the 30th June, 2025**

ENACTED by the County Assembly of Kiambu, as follows—

Short title

1. This Act may be cited as the Kiambu County Supplementary Appropriation (No. 2) Act, 2025 and shall come into force upon publication in the *Gazette*.

**Issue of KSh. 1,062,427,188.0 out of the County Revenue Fund for the
service of the year ending 30th June, 2025**

2. The County Treasury may issue the sum of **Kenya Shillings One Billion, Sixty-Two Million, Four Hundred and Twenty-Seven Thousand, One Hundred and Eighty-Eight only**, out of the County Revenue Fund and apply it towards the supply granted for the service of the year ending on the 30th June, 2025.

Application of the sum granted

3. The sum granted by section 2 shall be appropriated for the several services and purposes specified in the second column of the schedule, in the amounts specified in the third column of that Schedule.
